Bylaws and Rules of Governance

- May
1976 Latest revision of the Bylaws and Rules of Governance approved by the Board of Trustees in May 1976.
- Bylaws contain the essentials of College organization, policy, and operation.
- Rules of Governance are formal actions of the Board adopted to provide further policy direction.
- March
1974 Bylaws and Rules of Governance revised (following action by the Board based on the Report of the Commission on Long-range Plans submitted to the Board June 22, 1972)
- September
1967 Bylaws revised (In later revisions Rules of Governance separated from Bylaws)
- September
1930 Bylaws revised.
- 1929 Summary Statement by the Dean Respecting the Aims, Scope, Reading List and Examinations of the CLU Educational Program.
- October
1927 Bylaws as amended at a meeting of the Board of Directors (note-name of Board later changed to Board of Trustees as appropriate to an educational institution).

Articles of Incorporation Filed With Proper
Educational Governing Body

- 1976 Articles of Merger of The American College of Life Underwriters (a District of Columbia nonprofit educational corporation) into The American College (a Commonwealth of Pennsylvania nonprofit educational corporation filed with Recorder of Deeds, District of Columbia).
- Agreement and Plan of Reorganization under Section 368 (a) (1) (f) of the Internal Revenue Code date May 14, 1976 filed.
- Plan of Merger
- Charter Resolution
- 1975 Articles of Incorporation of The American College in the Commonwealth of Pennsylvania
- 1975 Application for permission to grant degrees, Commonwealth of Pennsylvania
- 1927 Articles of Incorporation—original articles filed in District of Columbia, United States of America with Board of Education, District of Columbia

Degree Granting

- 1977 March 16, 1977. Full degree granting approval by Commonwealth of Pennsylvania
- 1975 March 12, 1975. Approval to award degree Master of Science in Financial Services

1974 First of several state evaluating teams visit College. Officer for the Commonwealth negotiations: Warren D. Evans, Chief, Division of Graduate and Professional Programs, Pennsylvania Department of Education

1973 Application to the Commonwealth of Pennsylvania for degree granting authority through Department of Education

Accreditation of Institution and Degree Programs

1978 Full accreditation received from Middle States Association of Colleges and Schools

1977 Self Study Report prepared for the Middle States Association of Colleges and Schools/Commission on Higher Education

1975 College accepted as a candidate for accreditation
